Vendor to generate invoice based on all Comp. medals and send direct to Jaen. A short discussion was held on continuing to issue medals and the potential of finding something more useful.

Following a discussion on hosting future meetings Mijas offered to provide refreshments when meetings held at Mijas given that the travelling delegates incurred travel costs. Mijas requested that the other clubs reciprocated when they hosted a Federation meeting. The clubs agreed that Mijas was central location for future meetings, but meeting location to be confirmed by the Delgado.

Those Federation Committee members responsible for printing documents to advise Bixio of stationary and Printer Ink requirements for 2024. If not provided by FEB potential stationery costs €66/annum

4.5 Proposal on raising Operating costs-John Wilson.

Umpire & Marker Licenses have been paid at no direct costs to Individuals or Clubs. If we use Umpires local to the hosting clubs and that clubs provide food and drinks for the Umpires they should not incur any costs.

If each Umpire/Club hosting FAB events release the Umpire fees to cover the Operating costs this would raise €960.

We cancelled Malaga Training day 17 January and it has to be invoiced by Lauro per the budget. It is proposed that the funds received for 17 Jan be released to cover FAB operating costs. €170

Total potential funds €1130

Those club representatives present did not agree to the use of these payments to fund the Operating costs of the FAB Malaga. Matter to be discussed at a future meeting.

5. Budget from 2024 calendar & disparity of funds allocations to host clubs.

The 2024 FAB Calendar agreed prior to knowing Green day rates in 2024 Budget. La Posada were not present during the FAB meeting when Competitions were allocated and received only 1 of the 9 events. (That event was cancelled in 2023).

Of the Clubs that committed to host FAB events the following payments for Rinks rentals will be made per the Budget. Malaga Province Practice Day allocations were not discussed when the Calendar was set-but 8 rinks are required for the home Provincial Match, hence Lauro. How do we address disparity?

At the meeting La Posada shared the details of an email he had sent to Ron following the issue of the 2024 Calendar raising their concerns over their allocation of the President 4s. They acknowledged that one club would host fewer events. La Posada requested that Mijas and Lauro consider taking the President's 4s event in exchange for either the Malaga Provincial Trips - Lauro 7th-10th April or Summer Champs Trips - Mijas 27th-30th Sept.

It was proposed and agreed that the club who hosted the fewest events in the year prior would be given the first choice of what two events they host for the following year.

6. Confirmation FAB Competition Entry Fees for 2024?

The outgoing Treasurer submitted payments to Jaen in advance of Competition entry for the 2024 Calendar events and no further payments will be necessary to Jaen for this year (€2135). Payment made reflect a higher level of participation than in 2023.

Any funds generated from Competition Entry Fees in 2024 should not be held by the FAB Malaga, unless to cover Operating costs incurred in 2024.

Payment of those funds to Jaen will mean that we are not in line with our budget and would not be recoverable by our member clubs.

It was agreed by the club representatives in attendance that €5 Entry fee per person would be payable to the hosting club and that those funds could be called upon to pay the operating costs for FAB Malaga.

7. Compilation of Call Notices for 2024 events in absence of Competition Secretary.

Prior to issuing the Call Notices clubs need to agree the format of each Calendar event, Open or not and are singles events Open or Gender specific.

The club representatives in attendance agreed to all Federation Events being Open for 2024 (ie Teams can be from different clubs and any combination of genders). Singles events would be mixed gender.

It was agreed that the Skip named on the entry sheet would be responsible for commit to pay the entry fee once their team had been included in the Competition Draw.

Entry fees would be payable to the hosting club and that clubs Competition Secretary would be responsible for making the draw and be the Controlling Body.
